What is Health Functional Food?

Health functional foods are made using ingredients or components that provide beneficial effects to the human body or supplement nutrients that may be lacking in daily meals.

In Korea, all health functional foods distributed in the market are produced using ingredients that have undergone rigorous evaluations by the Ministry of Food and Drug Safety (MFDS), including human clinical trials and animal studies to verify their safety and efficacy.

These products are manufactured in compliance with Good Manufacturing Practices (GMP) and are subject to strict post-market monitoring, including pre-approval of functional claims and advertising, as well as traceability systems to ensure consumer safety.

Only products that pass these processes are allowed to carry the official Health Functional Food certification mark and functional claims on their packaging.

*Legal basis : Acts on Health Functional Food

Recognition Ingredient Types for Health Functional Foods

Nutritional Components (Authorized)

MFDS-standardized vitamins and minerals with defined functionalities and recommended daily intakes

*28 standardized nutrients, including 14 vitamins, 11 minerals, dietary fiber, proteins, and essential fatty acids, as defined

Functional Ingredients (Authorized)

Functional ingredients with established health claims and daily intake standards defined by the MFDS

*Examples : red ginseng, green tea extract, coenzyme Q10, etc. (Total : 68 types)

Functional Ingredients (Individually recognized)

Ingredients individually recognized by the MFDS for exclusive functional use

*Examples : collagen peptide, boswellia extract, ashwagandha extract, etc. (358 Types as of Dec. 2024)

Individually Recognized Ingredient System

A government approval system based on scientific evidence for functional ingredients. Businesses may intend to obtain recognition from the Ministry of Food and Drug Safety (MFDS) for health functional ingredients they have developed, by submitting scientific data regarding specifications, safety, and functionality. Once recognition is given, the ingredient can be used exclusively by the applicant.

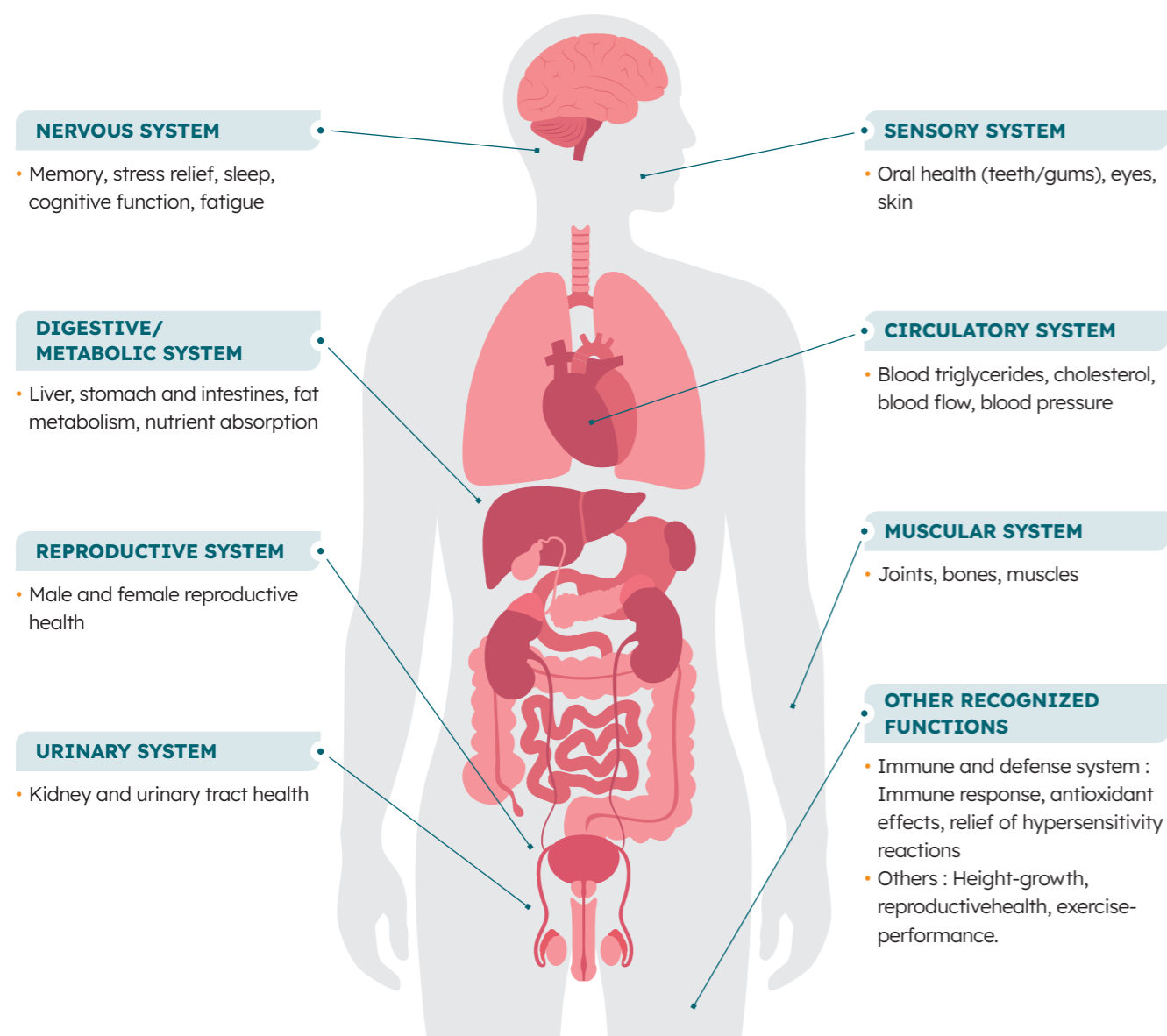
*Scientific evidence from animal experimentation, in vitro experimentation and human studies is required to prove both safety and functionality.

Functional Categories of Health Functional Foods

Category	Example of Functional Claim
Category Example of Functional Claim Nutritional Function	Provides essential nutrients that support human growth, development, and physiological functions. *Example : Niacin – helps produce energy in the body
Physiological Function	Helps maintain or improve normal body functions and biological activities. *Example : Green tea extract – may help reduce body fat
Disease Risk Reduction Function* *SSA-level scientific evidence required.	Helps reduce risk factors associated with diseases or abnormal health conditions. *Example : Calcium – may help lower the risk of osteoporosis

Types | Currently, 57 health claims have been approved (e.g., fat reduction, joint and hair health, child growth), with more being added continuously.

Quality Control of Health Functional Foods

- GMP certification mandatory for all domestic health functional food manufacturers (since 2022)
- Smart GMP system introduced in 2024 for automated recording and management.

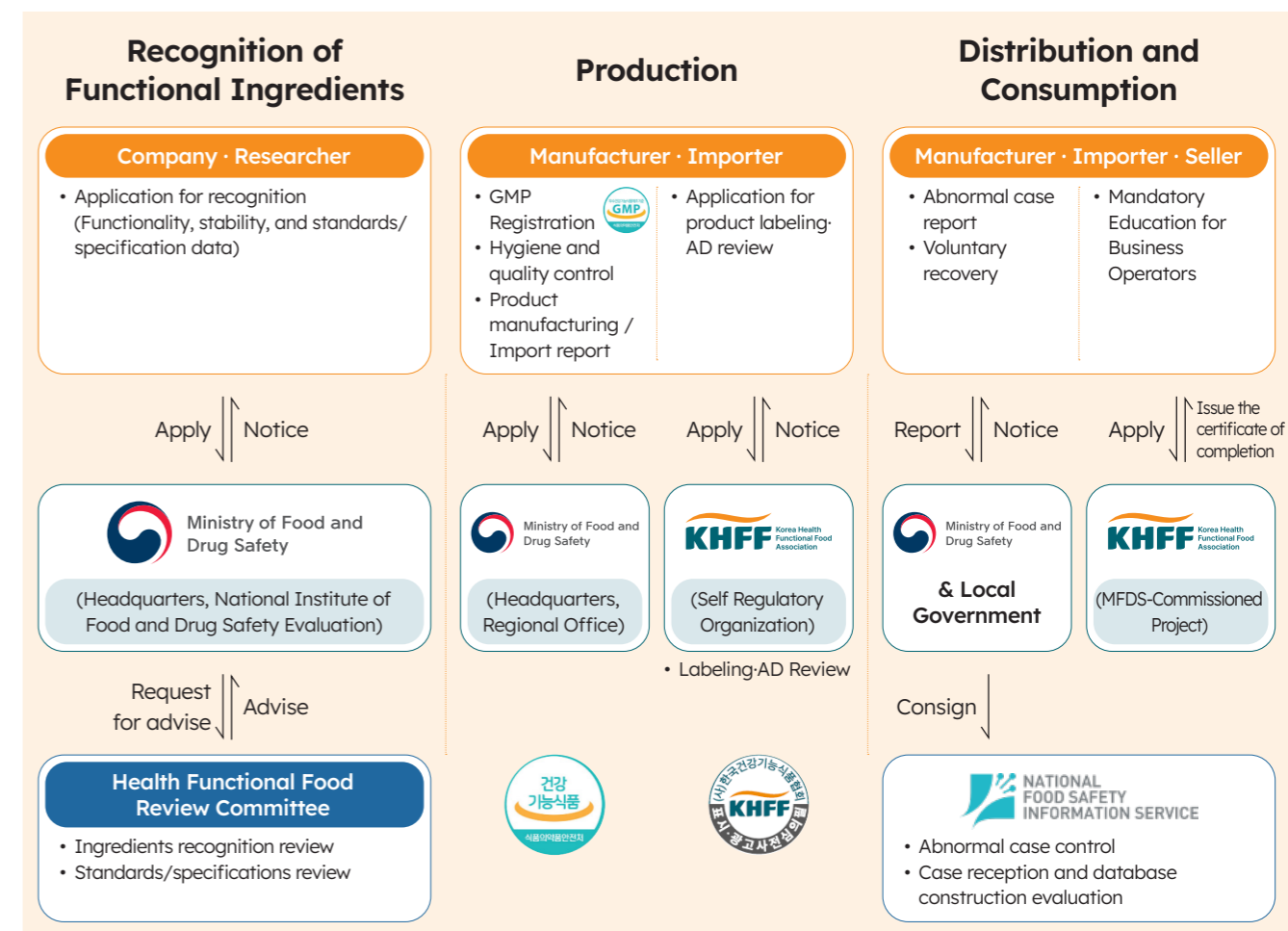
Prevention of False or Misleading Advertising

- Pre-approval of advertisements required to prevent consumer harm from false or exaggerated claims.

Post-Market Surveillance and Management

- **Adverse Events** Business operators are required to report any adverse events that occur after consumption.
- **Re-evaluation** Functional ingredients are re-evaluated every 10 years (or sooner if issues arise).
- **Ad Monitoring** Ongoing monitoring and enforcement against illegal advertisements.

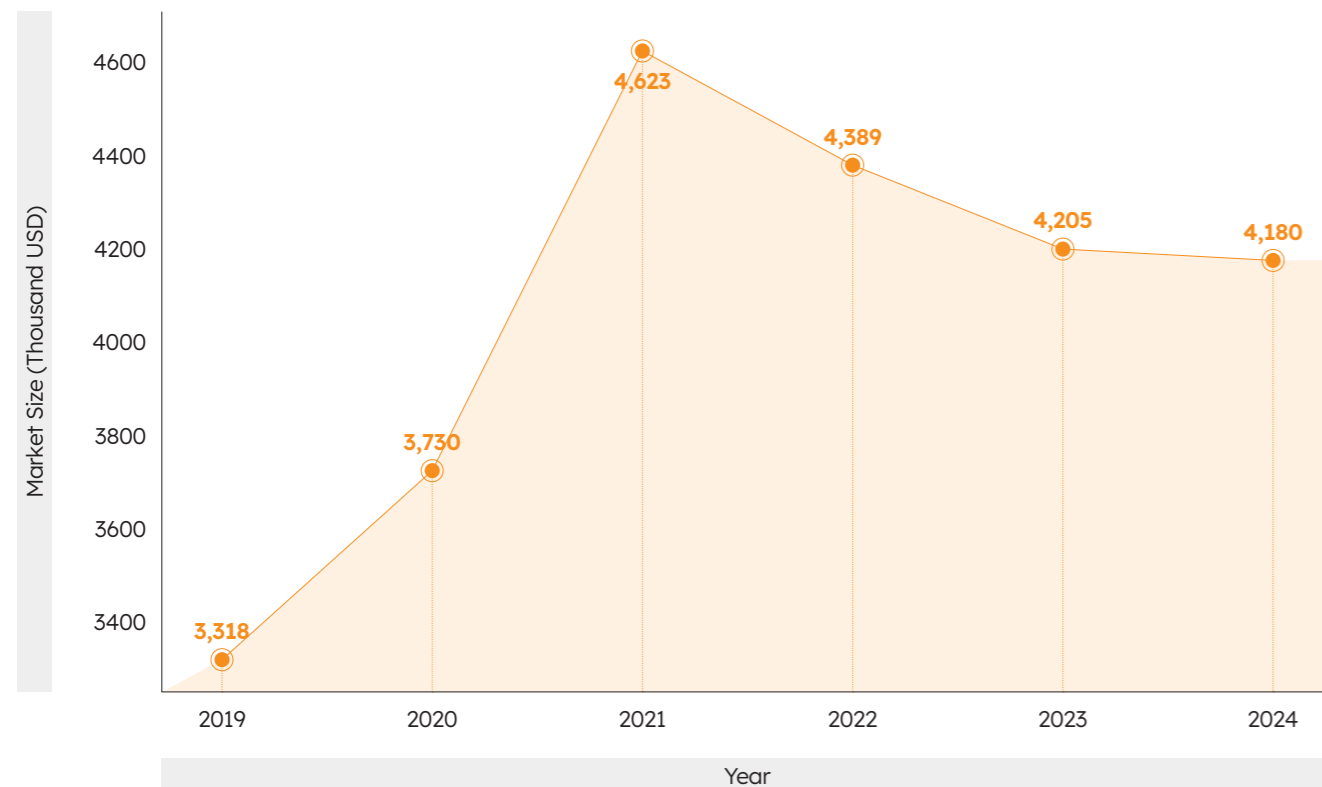


Korea's Health Functional Food Market Overview

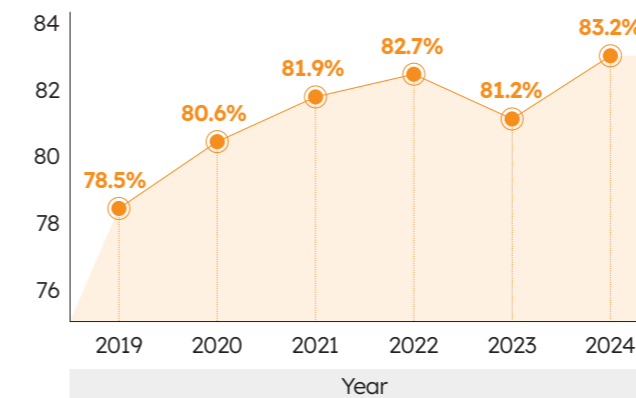

- With an average household spending of approximately 240 USD—consistently above 220 USD over the past five years.

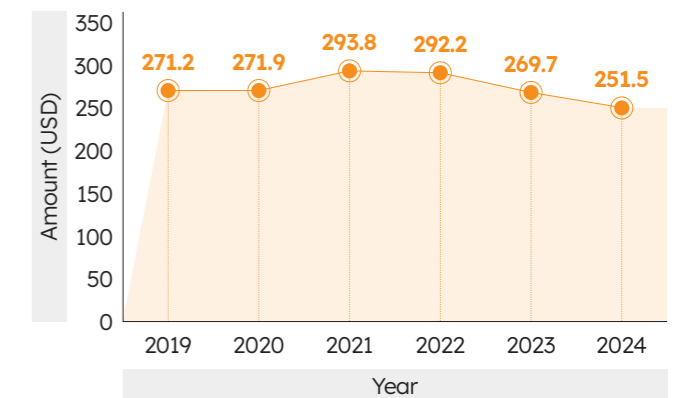
Purchase Penetration (%)

Average Purchase per Household (USD)

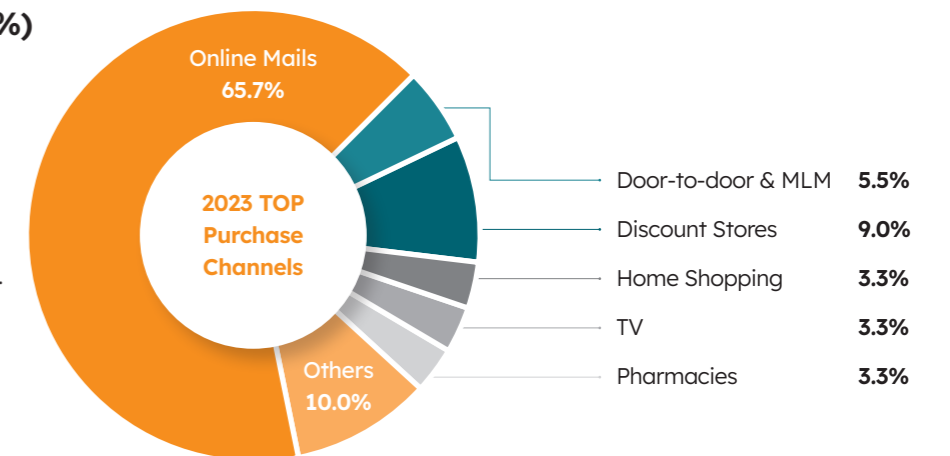
Annual spending per purchasing household

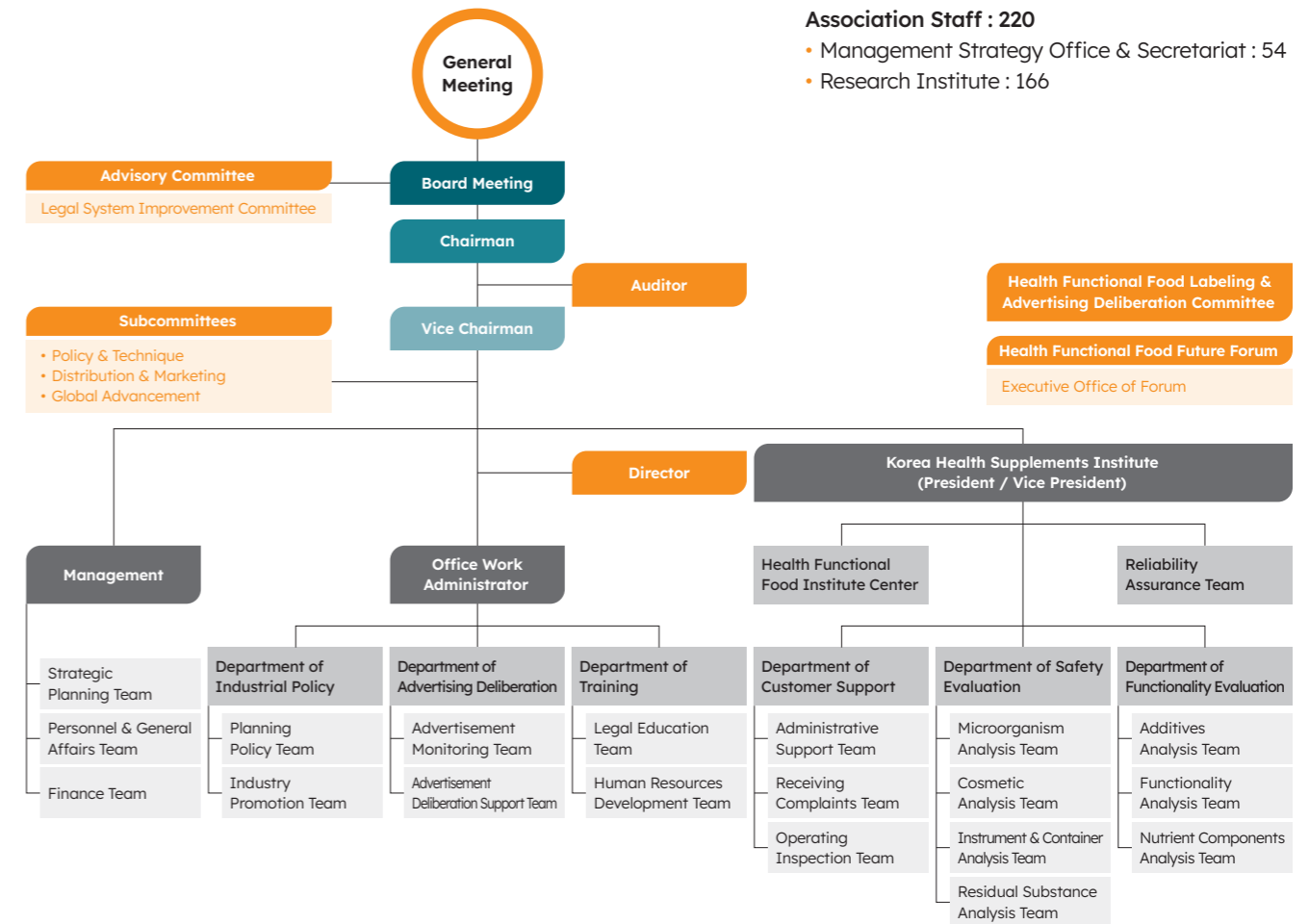


